Forecastle 2010 is expected to draw over 30,000 attendees from (44) states and (6) countries, with a nationwide media saturation campaign.

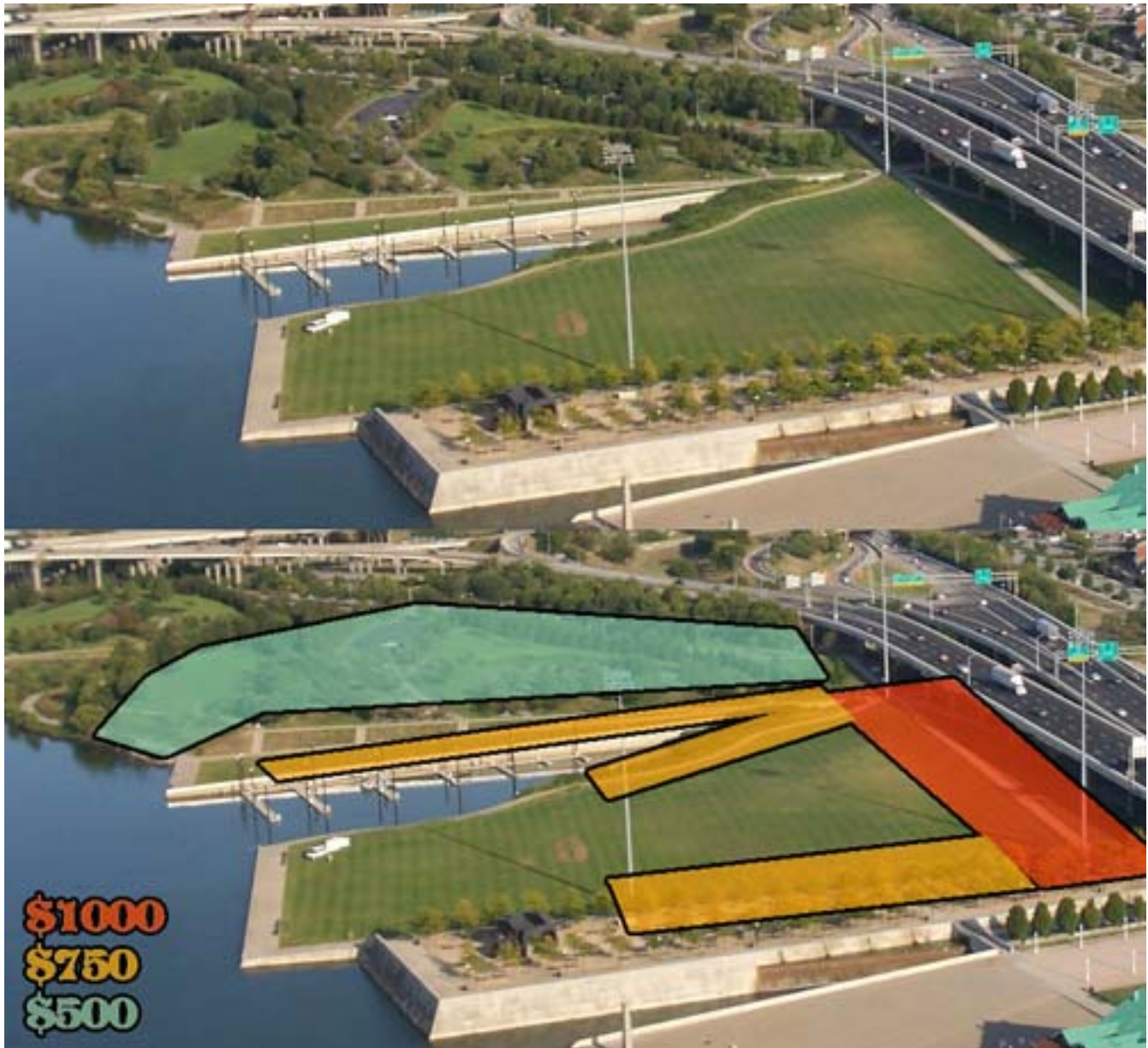

### V. POLICIES

In order to be considered as a vendor for The Forecastle Festival, you will need to abide by the following requirements, put forth by Forecastle and The Waterfront Development Corporation:

#### Location.

1. Please select among the (3) locations on the previous page.

#### Infrastructure.

1. \$1000 level - Forecastle will provide tables, chairs, and access to power.
2. \$750 level - Forecastle will provide access to power.
3. \$500 level - Forecastle will provide space.
4. Any / all additional items are your responsibility. Including, but not limited to: canopy for your area, weights to hold down canopy, staffing, lighting, etc. Be prepared. DO NOT ASSUME.

#### Security.

1. Forecastle will have overnight security to protect your area. Please have someone remain at your area until we have done a final sweep at night.

#### F&B

1. Do not bring food and beverages with you on-site, as they may conflict with an exclusive festival sponsor.

#### Environment.

1. As part of the activism component of the festival, we ask you to display their company's **SUSTAINABILITY PLATFORM** prominently at your vending location (ie. My company produces 100% natural products, my company supports a local food economy, etc).
